2004 Annual Meeting

The National Association of Rural Rehabilitation Corporations (NARRC) met for their Annual Meeting September 19-21, 2004, in Salt Lake City, Utah. The meeting was called to order by Vice President Paul Johnson. The Pledge of Allegiance was said. Johnson then introduced the Board, along with Kyle Stevens and George Hopkins from Utah. Roll call of the states was presented by Ila Deinert, Acting Secretary/Treasurer. Sixteen states were represented.

George Hopkins introduced Kyle Stevens, Deputy Commissioner of Utah, who presented an overview of the Utah Department of Agriculture and Food (UDAF) and some of its programs, such as:

- · Utah Egg Quality Assurance Plan
- Utah Cattle Health Assurance Program
- Utah Partners for Conservation

 Utah and Development Confined Animal Feeding Operation

Utah's Commissioner Cary Peterson gave an official welcome to all of the delegates.

Larry Lewis, Public Affairs Specialist - UDAF, spoke on open space and conservation in Utah dealing with growth, how to protect farmland and conservation easements. He stated that in 2004 the U.S. exported 60 billion in ag exports. Also, ours is the cheapest food in the world with ten percent of U.S. income going for food. He said in 1997, the U.S. lost 16 million acres of agricultural land to subdivision non-farm commercial development.

Seth Winterton, Investigator for UDAF, spoke on organic farming in Utah and how to add value to the products, have the convenience in products for the consumers, and how to increase organic production in Utah. Farmers have been expanding from several acres to large farms and are interested in interacting with the consumers. They are helping

people market their products as they see more people being concerned with the food they eat.

Dr. Jack Payne, Vice President Utah State University (USU) Extension, spoke on the how to preserve our natural resources with clean water and clean air. After lunch, Kyle Stevens introduced Debra Spielmanker, Director, Utah Ag-in-the-Classroom. She stated, we needed to improve agriculture literacy by increasing student awareness on agriculture, because agriculture affects our quality of life and our environment. We were then given a small test on our knowledge of agriculture.



Mark Habbeshaw, County Commissioner of Kane County, spoke on entitlement of the Grand Staircase National Monument and how this has locally affected Utah with road issues, grazing elimination, and water wildlife. Kane County was designated a national monument during the Clinton Administration.

Dr. Ralph Whitesides, Plant, Soil, and Biometeorologist Department from USU, spoke on difficult conversations. He stated a difficult conversation is anything you find hard to talk about. He showed that on an average day, the dilemma of difficult conversations, whether to

avoid or confront them in everyday life. How some of them lead to mediation, stating that difficult conversations are a normal part of life. He gave us three basic listening skills:

- Inquire to learn, which means get more concrete answers;
- Paraphrasing for clarity, show that you hear; and

Acknowledge the other person's feelings.
